Billingham United FC in all its activities will not discriminate, or in any way treat anyone less favorably, on grounds of gender, sexual orientation, marital status, race, nationality, ethnic origin, colour, religion or belief, ability or disability. It means that Billingham United FC will ensure that it treats people fairly and with respect and that it will provide access and opportunities for all members of the community to take part.

Billingham United FC will not tolerate harassment, bullying, abuse or victimization of an individual, which for the purposes of this policy and the actions and sanctions applicable is regarded as discrimination. This includes sexual or racially based harassment or other discriminatory behavior, whether physical or verbal.

Billingham United FC will work to ensure that such behavior is met with appropriate action in whatever context it occurs.

Billingham United FC is committed to taking positive action where inequalities exist and to the development of a programme of ongoing training and awareness raising events and activities in order to promote the eradication of discrimination and promote equality in football.

Billingham United FC is committed to a policy of equal treatment of all members and requires all members to abide by and adhere to these policies and the requirements of the relevant equalities legislation- Race relations act 1976, sex discrimination act 1975 and disability discrimination act 1995 as well as any amendments to the acts and any new legislation.
